For myself, my heirs, executors, administrators, legal representatives, assignees, and successors in interest collectively "Successors")I HEREBY WAIVE, RELEASE, DISCHARGE, HOLD HARMLESS, AND PROMISE TO INDEMNIFY AND NOT TO SUE the Releasees and the sponsors of the DIV 62 or any DIV 62 related event or the event's organizer or any promoting organizations, property owners, law enforcement agencies, all public entities, special districts and properties, and their respective agents, officials, committee members officers, directors and employees through or by which the events will be held, the foregoing are also collectively deemed to be Releasees. FROM ANY AND ALL RIGHTS AND CLAIMS INCLUDING CLAIMS ARISING FROM THE RELEASEES' OWN NEGLIGENCE, which I have, or which may hereafter accrue to me and from any and all damages which may be sustained by me directly or indirectly in connection with or arising out of my participation in or association with the DIV 62 and any DIV 62 related event.

I understand and agree that situations may arise during the physical activities of the event which may be beyond the immediate control of the DIV 62 or DIV 62 committee members or organizers, and I must recognize this so as to neither endanger myself nor others. I accept responsibility for the condition and adequacy of my equipment. I have no physical or medical conditions which to my knowledge would endanger me or others if I participate in this event or would interfere with my ability to participate in this event.

Every term and provision of this agreement is intended to be severable. If any one or more of them is found to be unenforceable or invalid, that shall not affect the other terms and provisions, which shall remain binding and enforceable.
